6) Committee Reports (Secretary)

Budget Committee: Lena Najarian Kaderali said the group met in June to propose a draft budget and goals for the year. There was a focus on Community Improvement Projects (CIPs), Neighborhood Purposes Grants (NPGs) and providing food and beverages to increase attendance.

Government Affairs Committee: Barbara Ringuette said that every month she meets with a work group to ensure that our neighborhood goals are understood in advance of the Community Plan update, which is a 3-5 year process. There are many opportunities for community input.

Several neighborhood councils have been attending pre-planning meetings and PlanCheck meetings.

She highlighted the Echo Park Neighborhood Council survey being conducted at the Lotus Festival this week as an example.

The work group is preparing to meet with City Planning. We must let the planners know what we like about Silver lake, what we want more of and less of.

Speakers from City Planning will discuss restaurants/beverages policies. There is also concern about the unification of kids separated at border. Also, Council Member David Ryu has ideas about how neighborhood councils should work.

(Note: Anthony Crump has arrived.)

Arts and Culture Committee: Renee Dawson said that because of Dulce Stein the Committee has the spark that it needs now. There have been some things that spilled over from the last administration. She wants to continue them. She mentioned the Learning Hour in collaboration with friends from the library and having someone watch kids for parents during meetings.

From last year, she mentioned pointing out stars in Silver Lake and what they do and getting proclamations for outstanding Silver Lake citizens.

Regarding the Monarch butterfly project, she said that the Green Committee discussed this. Finally, she said mentioned a silent dance party to be held in Silver Lake Plaza.

Green Committee: John said the group wants to engage and empower stakeholders for sustainability and green spaces. Climate change is what we're all about. He said that there are several projects underway, including street clean ups, urban forestry to keep trees as canopy, and rehabilitation of the Silver Lake branch library garden by replacing old plants with native plants.

The Monarch butterfly project will be around the stairway. We want to do education about their migration. We will come to the SLNC to seek funds for education.

He said that a rodenticide ban is desired. There has been a huge legislative victory toward this goal. Animals eat the rats and they die and we can't allow that.

History Collective: SLNC Secretary Seth Copehaver read a statement from the group: They held a May 23 meeting where they re-elected their

cochairs. They meet on the first Thursday of the month. However, there is no meeting in July or August.

The statement mentioned a Silver Lake branch library event on June 6 about red cars. A historian spoke. In December the group screened a film about an historical gay bar in Silver Lake. The library recreated a piano bar. There was a huge crowd and live performances. The group has also partnering with the Getty Museum for a project.

Latinx Committee: Dulce Stein said the group will reach out to those who need representation in the neighborhood council. All meetings will be in Spanish. She is excited to begin this journey.

LGBTQIA Advocates Committee: Maebe A Girl said the group's first meeting will be July 25 at the Silver Lake branch library at 6pm. We want a great turnout. We will decide co-chairs and goals. Everyone is welcome.

Adult Advocates Committee: SLNC Secretary Seth Copenhaver read a statement. In 2016, the neighborhood council set up this group for the needs of seniors. We advocate for the City's older residents. We have a motion tonight for a bridge housing project on Riverside Drive. A Coffee with a Cop session will be held on Thursday. For Co-chair elections, there were no candidates. So Stephanie Vendig and Nina Sorkin will continue to lead. We want SLNC recommendations regarding purposeful ageing. The group is also concerned with emergency preparedness and resilience for a natural disaster. We need to address the needs of seniors for this.

Business Committee: Lorraine Getz said this is a defunct group. I want to reunite local businesses in Silver Lake. She will formulate a group. There is a lot of interest. We will showcase local businesses. Without them Silver Lake would not be what it is. We want to know how we can support business and how they can support us.

Outreach Committee: Nicholas Fox-Robbins said that the group is revamping its newsletter. Their next meeting is tomorrow at 7:30pm at the Silver Lake Recreation Center. They are dedicating the entire meeting to improving the website. He said that he is very impressed with the Los Feliz Neighborhood Council website.

Their next meeting will consider how the location of SLNC meetings affect representation of lower income community members and those who live south of Sunset Boulevard. The date has yet to be determined. We are working with Dulce Stein's new Latinx Committee about that. He mentioned the creation of a banner in Spanish about the SLNC. That's the first step.

Reservoir Committee: Sarah Ullman said the group is focused on outreach around the Master Plan process. Efforts include canvassing, fliers, and advertising on social media. Outreach is a crucial function. There will be a document for the website with up to date information. Most people don't know that there's a Master Plan process. We are also looking to turn outreach materials into Spanish.

For the dog park, she mentioned new pooper scoopers and new signage. There are also discussions with Council District 13 (CD13). There are also discussions with the Parent Committee and an ad hoc committee for the DWP modular office building, July 18 will be first meeting for that.

Transit and Safety Committee: Paul Emmons said that Cameron Bard is the new co-chair. On June 22 we met with residents at Council Member Mitch O'Farrell's office and the Department of Transportation. Cut through traffic on Earl Street was the topic. We also met with the new LAPD Senior Lead Officer Jesus Hespera, who is taking over for SLO Lenny Davis. We also met with LAPD Captain Sandoval.

On June 13 there was a meeting about the Kingley Horn study about changes to Rowena. Council Member Ryu supports this. Both motions passed unanimously in SLNC Committee. There are discussions about the conversion of Angus to a one-way street to eliminate cut through traffic. The Transit Committee and SLNC don't have a preference. We're just trying to gather public information. We need to identify funding.

Urban Design and Preservation Committee: Liza Temple said the group had a heavy agenda last month. She mentioned Transit Oriented Communities (TOC) developments. They aren't obligated to come to our committee. Developers presented a project with 104 units on Sunset Boulevard that includes 9 low-income units. They listened to our feedback.

She added that there was also a 6-unit small lot subdivision on Rowena. We voted to table that and to ask them to return. There are also three letters regarding the demolition of a building wanting to preserve the Tokyo Florist Building and to preserve a hill in Echo Park. The Committee will next meet August 14 to discuss a small lot subdivision, Conditional Use Permits (CUPs), and an old El Pollo Loco.

9) New Business

a) (Secretary) Move to select a Region 1 representative to fill a vacancy due to the resignation of Doug Loewy effective June 18, 2019 announced just prior to the Special Meeting of the Governing Board.

Candidates:

(1) Jose Mendoza

(2) Adam Sieff

Adam Sieff withdrew from candidacy.

Tina Lin is also a candidate.

Jose Mendoza:

He read the declaration that he'd submitted to the neighborhood council. He's lived in Silver Lake since 1984 and owned property here since 1997. He's interested in helping the community address problems with crime, homelessness, and tenants. He wants to see rising property values. He has a wife and kids. He's a graduate of UCLA and Loyola. He's a real estate trial attorney. He owns apartment buildings. He is Treasurer for his tenants' association. He's a member of the California Association of Realtors Forum. He wants to make Silver Lake the best it can be.

Tina Lin:

She's been a homeowner in Silver Lake for the past 7 years. She lives behind the Salvation Army Project. She rents one unit of her two-unit property to long term tenants. She loves that her street has both renters and homeowners.

She's a former architect who attended the USC Masters Program in real estate development. She is now with the Sunset and Gordon tower in Hollywood. She's learned a lot from that process for the controversial project.

She has a financial background. She currently works for a non-profit and builds for charter schools. She's served on two nonprofit boards in the past for a pro bono law firm. She is also an Asia Pacific Women's Center board member. I would love to help out, she said.

Mark Duncan asked both candidates what is the Board's role in making Silver Lake better for you?

Tina Lin said the committee reports were a good example. It's communication and facilitating difficult questions that we are all facing.

Jose Mendoza replied that education is what drives people into our community. From a real estate perspective, people look at school districts, safety, beautification, etc.. I've lived here for 35 years. I love that you put effort into beautification.

Ilanthe Zevos asked is that an issue that motivated you to join now?

Jose Mendoza said there is no particular motivation for now. My kids' in college so I'm an empty nester. I now have time. Before my plate was too full. I can now give back to the community. I

volunteer on other boards too. I have the time. It's time for me to step up.

Tina Lin said she's had concerns over the years. She's been to the Urban Design and Preservation Committee meetings a couple of times. She had a discussion with Nicholas Fox-Robbins yesterday. He said there is a new wave of making positive change that is welcoming to all residents. She's concerned about retail and commercial vacancies along Sunset Boulevard. Greedy landlords are holding out for higher rents. That can cause blight. She wants good development.

Sara Ullman asked the candidates, what can we be doing better as a board?

Tina Lin said outreach is key. That's already happening. Going to the Farmers' Markets is great. Citizens would want to be involved but they aren't getting information.

Jose Mendoza said membership and outreach. I only hear about the SLNC through an email list that I stumbled upon. Others are probably unaware too. There was then discussion with Nicholas Fox-Robbins about enhancing the webpage.

Paul Emmons asked the candidates about the future of the Silver Lake Reservoir?

Jose Mendoza said I don't know what will happen with the Silver Lake Reservoir. He asked about that. Board members replied that said we don't know yet. He said if one of the proposed uses is recreational that would be great but he expressed concern about the possible negative impact regarding traffic, crime, parking, resources.

Tina Lin said that all of those topics are very relevant. I'm not up to date with the Reservoir. I understand that it's very controversial for immediate neighbors versus Silver Lake at large versus visitors. I wrestle with questions about what I would want there, even a bathroom. Bathrooms can be damaged and vandalized. I would like to participate in figuring out what is best.

Seth Copenhaver said you are both really great candidates. That's a good thing. We're attracting the right type of people.

Elaine Harris Roark asked about the candidates' Region 1 agenda.

Jose Mendoza said I don't have an agenda. He said that he wants to make the entire community more loving and accepting.

Tina Lin said retail vacancies on Sunset. The housing crisis affects diversity in our neighborhood. She is also concerned about education.

Nicholas Fox-Robbins asked what is the role of the neighborhood council in supporting the arts in Silver Lake?

Tina Lim said I appreciate students here working on musical arts. She mentioned public art in private development. The neighborhood council can make known their desire to shape that art, to have local art for residents.

Jose Mendoza said that he's a sponsor for anything related to the arts. His family loves musicals. He loves small theatre. Anything you can do to help the arts is admirable. I was a DJ in high school and a former break dancer, he said.

Maebe A. Girl said I encourage both of you to get involved in our committee system. What committees interest you?

Tina Lin said the Commercial Business Committee. She mentioned connecting with the Silver Lake Chamber of Commerce, recognizing that there are business owners who are not involved with the community here. She is also interested in the Urban Design Committee too.

Maebe A. Girl asked Jose Mendoza you own apartments? How many units? Do you have low-income units? Mendoza responded that I own 10 units in Lincoln Heights. They are rent-controlled. I bought them about 5-6 years ago. They are two bedroom units next to the Brewery. The rates are \$650-\$700 per month, very affordable. We've very mindful of our tenants needs. I understand tenants and landlords perspectives.

Dulce Stein asked him about strategies to help the homeless community? Mendoza said that based on my church role, I see that we would offer a resource center where the homeless can go for basics: showers, toiletries, post office boxes, job training, etc.

Tina Lim replied that education to constituents who are not homeless about issues facing the homeless. LAPD sweeps are not effective. She works with a public council helping homeless.

Barbara Ringuette said they are two excellent candidates. I hope that each of you will become involved in committees. She wants Mendoza involved with homelessness in the Silver Lake group and in SELAH. Our tenant and housing group could use your expertise. Tina Lin should be involved in Urban Design.

John Darnell made an announcement about housing and tenants rights. We did a town hall. DONE hosted a purposeful ageing town hall last year.

Regarding business, neighborhood council representative and City departments would come out to explain how we can help businesses. There is a difference between outreach and engagement. You can actually go and talk to people. Engagement is a two-way street. He said he's happy to help set up town halls.

Jane Hook said I don't envy you. Frida Chen said both of them are terrific candidates. You are both diverse candidates like myself. What do you like to do in your spare time, what relaxes you? Tina Lin said eating. Jose Mendoza said travelling and cars are his vices.

John, a former neighborhood council member, said that he is thrilled with both candidates' qualifications. You both have a real estate background. What about conflicts of interest relating to development.=?

Jose Mendoza said I don't own any real estate in Silver Lake. I represent developers buyers and investors. I don't see any conflicts. I'm mindful about impacts on community and affordable housing.

Tina Lin said the developer I work for is no longer active in Los Angeles. Also, she works with a bank and with a non-profit for charter schools. However, no charter school can afford to be in Silver Lake so I don't see any issues.

Liza Temple said I want to encourage both of you to join the Urban Design and Preservation Committee. What could the Urban Design and Preservation Committee do better regarding housing development?

Tina Lin said that City Council members are not fair. She wants to require developers to come and make deals.

Jose Mendoza said that for urban development there has to be concessions. I want them to give back, maybe entitlements.

5) Presentations

a) CD4 report, Rachel Fox -- REVISITED

*Rachel Fox, Field Deputy, Council District 4, Council Member David Ryu:*

City Council is relatively quiet with the summer recess.

Last year, we had a heat wave during July 4, this year earthquakes.

Council Member O'Farrell, Council District 13, introduced a motion to the DWP for upgrades for outages for older neighborhoods. Now you can log onto your account to sign up for notifications for power and water outages. You can sign up for up to 3 locations at [www.ladwp.com/outages](http://www.ladwp.com/outages).

Prior to the recess, Council Member Ryu introduced motions to address the housing crisis. She mentioned the Ellis Act. This reduces the market size of rent stabilized units. We've lost 25,000

rent stabilized units. They are critical for not displacing people. We are looking at tenant relocation expenses. We are seeking reports for that.

We are also looking at the City's regional housing needs for low to moderate units. We have a lot of incentives for low-income units but not moderate housing. We want to increase that middle income housing. About 220,000 Angelenos spend 50% of their income on rent. She wants a vacancy tax motion like Vancouver and Oakland.

The playground in Griffith Park is being upgraded. It opens July 20. We'll be there. Council Member Ryu will be there.

The Los Feliz Neighborhood Council and SELAH, a local coalition of neighborhood councils focused on homelessness solutions, is having a presentation on July 17. There will be discussion about what the City is doing for the housing crisis.

Regarding stories from the Frontline. She urged to create empathy with people experiencing homelessness. There will be an event for this in Hollywood on July 18 at 6:30pm at the Wanderlust Yoga studio. There will be food.

Regarding the Bridge housing site on Riverside Drive, Council Member Ryu introduced two motions: to look at the feasibility in each Council District. They are going through the feasibility study now. The Hollywood earthquake fault line runs through the proposed Riverside Drive site. We are also looking at the feasibility of having a senior center at that same location, or perhaps a community center.

Ryu also introduced a motion for DWP and the Department of Recreation and Parks to look at opening Rowena Reservoir to recreation use. There is some interest.

She said there will be a homeless presentation at the Franklin Auditorium on Riverside drive.

Paul Emmons asked about outage information. What about tenants? Fox said we're check with the DWP about that. He asked about the Ellis Act. Those units are removed from the rental market for only two years? Fox said the tenants have a right of return. Taryn Poole mentioned an: increase of tax credits for rentals.

## 9) New Business

a) (Secretary) Move to fund NPG in the amount of \$250.00 to commemorate the 1-year anniversary of Melyda Corado who lost her life on July 21, 2018 in a shooting and hostage situation at Trader Joe's:

i) Silverlake Community Church is organizing a memorial service, a "block party" and candlelight vigil to commemorate the one-year anniversary of the shooting and hostage situation at the Trader Joe's in Silver Lake on July 21, 2018. The event, which is open to the public, will take place on Sunday, July 21 from 4:00pm to 9:30pm. The purpose of the grant from the Silver Lake Neighborhood Council would be to help pay for food, which will be supplied from local businesses and served during the "party" portion of the even immediately following the memorial service from 4:00pm-5:00pm.

*Seth Copenhaver made the announcement. Paul Emmons seconded.*

Goudsmith said this is an NPG application.

Nicolas Fox-Robbins asked is the money going to the Silver Lake Community Church? Goudsmit said yes. The nonprofit will receive the money.

Mark Duncan said it seems that Trader Joe's has plenty of funding for this. Goudsmith explained that the church is organizing the event. Trader Joe's is participating. The money is for food during the ceremony.

Taryn Poole said I live above Trader Joe's. it was a horrific day. This is a great gesture to do this. Some people remember it like it was yesterday. Sarah Ullman said that providing food is an attempt to bring people together, according to the NPG document. Paul Emmons said that he supports this. He attended the memorial service. It's a huge deal for the community.

Tina Lin asked how did you arrive at that amount?  
Goudsmit said that's what they asked for.

b) (Stein) Move to approve the proposed mission statement of the Latinx Representation Committee. Proposed Mission Statement: The Latinx Representation Committee is dedicated to increasing civic involvement of Silver Lake's Latinx community, ensuring the Latinx stakeholders of Silver Lake are equitably served by the Neighborhood Council, and fostering awareness of the resources that are available to them. Vision: While the Latinx community in Silver Lake represents somewhere between 30-40% of the neighborhood population (and had previously been even higher), they are dramatically underrepresented and under-served by the Neighborhood Council. The Latinx Representation Committee will take concrete steps, small and large, to ensure that the Silver Lake Neighborhood Council be of service to all Latinx stakeholders encouraging participation through empowerment. Several strategies will be employed to meet this goal including a survey of organizations currently serving the Latinx community in and around Silver Lake, forging relationships and partnerships with churches, schools, clinics, businesses, and organizations where the Latinx community spends their time, working to make Neighborhood Council events more accessible and inviting for the Latinx community, and door-to-door grassroots organizing. Values: The

Latinx Representation Committee stands for: Participatory Democracy, Equitable Representation, Community Empowerment.

Dulce Stein read the mission statement.

*Taryn Poole seconded Dulce Stein's motion.*

Maebe A. Girl said I express my wholehearted support for this. I can't wait to see what it brings.

Taryn Poole said there are so many ways to integrate this community into the neighborhood council. I'm very excited. Tina Lin said I hope that it's translated into Spanish and disseminated widely. Dulce Stein said all meetings will be in Spanish.

There is also a letter to Council Member Ryu regarding the development of City property for temporary housing and services, Bridge housing. The letter applauds this.

Jane said the Transportation and Safety Committee should also be involved. Riverside Drive is awfully busy.

Nicolas Fox-Robbins commented about the second letter to Council Member Ryu. In the second paragraph, in the second sentence, he is confused. He made a motion to reword this to “we hope to see the development of crisis and bridge housing” is the rewording.

Sara Ullman said that she is curious about the location. Fox said the model is to try to house people living near the site. This site addresses people living around the LA River. Extensive outreach will be done in the area.

Ullman asked about temporary housing? Will there be no need in 3 years? Fox replied that the expectation is that in 3 years, Measure HHH housing units will be approved and getting people off the streets. About 7,000 units are in the pipeline. We have housed 21,000 but more people fell into homelessness.

Ullman said you have my support but I'd like more housing. Fox said we're always looking for more housing. We're looking at public properties. We are open to suggestions. Council District 14

is working with a warehouse downtown. We're holding small group meetings on a bridge housing site.

Tina Lin asked about the location of the homeless. Elaine Harris Roark said this looks like parkland. Fox said it will go onto a parking lot. No trees will be removed.
