3. Welcome and rules for actions on agenda items

4. Public Comment on Non-Agenda Items

Silver Lake Neighborhood Council (SLNC) Co-Chair Anne-Marie Johnson said that the group's next Board meeting will be held on the second Wednesday of July, July 11, because of the Independence Day holiday on Wednesday, July 4.

Betsy Isroelit said there was a story in the SLNC May 22 newsletter about signs being available. Anne-Marie and I have since delivered about 50 of them. There are about 15 left if you need them for your region. Johnson said about 65 signs were printed.

(Note: Antonio Stifano, Glen Harrell, and Heather Carson arrived by 7:07pm.)

Heather Carson said that she was late because the parking lot is locked. It may be the fourth time in the past year that this has happened. Every time I'm late, this is the reason. I will file an ADA (Americans With Disabilities Act) complaint. Johnson said you have that right. However, the lot has been open for prior meetings. It would be unfortunate to penalize the Board and the school for this. People were moving trash cans and that was a concern for the school. So, we agreed to close the gate. Jerome Courshon asked whether going forward, should the Board put trash cans back outside?

David Wheatley, a member of the Urban Design and Preservation Committee, said that he wants to ensure that land use items come with the conditions assigned in Committee.

5. Special Presentations and Reports from City and State representatives.

John Darnell, Department of Neighborhood Empowerment (DONE):

He handed out a fiscal year review from the Department of Public Works. He told Betsy Isroelit that the inventory deadline can be in mid-July.

For the next meeting, add a Resilience Officer. The City of Los Angeles is funding a resilience plan with its departments and the neighborhood councils. Every neighborhood council must have a resilience plan by 2019 to deal with drastic changes and emergencies like climate change.

(Note: Antonio Stifano arrived at 7:12pm.)

Los Angeles is one of about 100 cities in the world looking at this. The Rockefeller Foundation has encouraged this. The goal of the Ready Your Neighborhood program is to get a block ready for a disaster. Others will see that and follow suit, said Darnell.

Johnson asked when must the liaison position be placed on the agenda? Darnell said that there will be a town hall meeting in August so definitely by July. The Board Chairs will be the default liaisons.

Johnson said that some Board members need to do funding but there is no mechanical way to prove that a Board member took training. Darnell said to click on the link below the YouTube training video. Take the test and the certificate will be recorded, said Johnson. Darnell noted that for treasurers, second signers, and bank card holders you have to take the training in person.

(Note: Lee Sherman arrived at 7:16pm.)

Jerome Courshon asked whether the document that Darnell handed out can be delivered as a pdf so that it can be placed online? Darnell said that he'd email that to the Board. Courshon also asked how many affordable housing guidelines units are being built yearly? Darnell replied that two years there wasn't a complete list. He doesn't know whether they do yet. The City didn't really track that. But in 2016 the Mayor made housing a big initiative. That's something that's supposed to come out. You can call the housing department for information. Courshon said they don't know.

Darnell suggested to call Council Member David Ryu's office. He's Chair of that committee. Courshon said that that's a good idea.

Seamus Garrity, Field Representative for State Assemblywoman Laura Friedman, 43^d District:

He mentioned Proposition 68 and said that the Assemblywoman has achieved a major victory regarding funding of \$20mln for a bridge connecting Glendale's Flower Street to the Los Angeles River, creating a transit corridor from Glendale towards downtown Los Angeles. There is a media advisory coming. Separately, he said that there will be an updated legislative overview coming out once bills are signed.

Rebecca Rubin asked about legislation AB2925. Did she vote on this? Garrity said that the Assemblywoman was deciding but her vote wasn't logged in. Heather Carson asked can she make a clear statement?

Scott Plante asked about RSOs (Rent Stabilization Ordinance). He is concerned with the lack of a sound wall. Garrity said he will sit down with CalTrans and Metro on Monday to address that. A sound wall would cost \$10 mln. That's up to \$650,000 per person. It's a large amount of money. He'll find out why they were against it.

Rachel Fox, Field Deputy for Council Member David Ryu, Council District 4, Rachel.fox@lacity.org, (213) 473-7004, (323) 957-6415):

She spoke about an ordinance that limits loudspeakers for communities affected by tourism. We've been working on this for a long time. It will take about 4-6 weeks to take effect. Thereafter, we'll begin citing tour buses.

Separately, she said that a bridge housing project in Hollywood has been approved. We are seeking other temporary affordable housing units.

Additionally, she said that the sidewalk rebate program is about to end. You must apply by June 30. It's really easy. You can apply at the City's 311 website to get in the queue.

After the community meeting for the reservoir, people were concerned about expansion of the footprint of the DWP installing the modules. It's still in planning. The Council Member met with Marty of the Department of Water and Power (DWP) today. That's still on our plate.

Separately, the Council Member wants to change the neighborhood council system. She wants to strengthen it. She wants to identify City spaces that neighborhood councils can use. She wants to change name of the Department of Neighborhood Empowerment (DONE). She wants you to submit a Community Impact Statement (CIS) about this.

Asking about a meeting with Council District 4 and the DWP, Johnson said that it would be great to be involved through our liaison. We receive the emails about this too. However, the last time that the DWP came here the reservoir project was presented as a done deal. We're surprised to learn that it's not a done deal.

We've been getting lots of push back from the City, said Fox. There is concern about the impact on the neighborhood with additional vehicles coming in and out. The DWP is pushing forward with design for the modules. Betsy Isroelit said that it would be great if you can keep the

liaison informed. Jerome Courshon added that we didn't see the pushback until this week.

Isroelit said we had 3 major community meetings about the Reservoir Complex and suddenly this comes up and we don't know about it.

Lee Sherman asked about a CIS deadline. Rachel said it wouldn't be for at least 90 days. So the deadline would probably be by the end of the summer.

Courshon asked Fox how much money is allocated for neighborhood councils for next year? Darnell said same amount. Courshon also asked about reservoir modules. Isroelit said according to the current Master Plan, DWP can staff their own property as they like.

Barbara Ringuette, Budget Advocate:

She said that Budget Day will be Saturday June 23, We have RSVPs from the Mayor's office, City Council Member Krekorian, City Council President Wesson, DONE Administrator Gracie Liu, the BONC President and Ron Galprin, among others.

This will be a big event with a catered breakfast. There will be a plenary session with speakers including herself. Then attendees will break up by region when you can discuss services and concerns. Everyone is invited but you must RSVP on our website or at www.ncbala.com, the budget advocate website.

6. Treasurer Report and MER

Treasurer Jackson said 119 applications to date have been submitted. I look forward to working with Valdez. We have about \$1825 unspent. There is about \$1183 due to Appleone. We have two more payments to make. There is also the cost of the newsletter. There will be about \$68 unspent after all that to finish the fiscal year at the end of June.

By contrast, he noted that collectively 17% of all neighborhood councils' funds have not been spent to date. That's about \$705,000 unspent. About 33% of the dollar amount of all funding applications have been denied across the neighborhood council system. Everything I do in my firm, two people look at it. We will spend all our funds. There will be nothing left over.

9. New Business:

9.1.(Transpo & Neighborhood Safety) The Committee requests that a letter of support be drafted by SLNC Board Co-Chair, Anne-Marie Johnson to Councilman Ryu asking that the City Attorney consider filing a lawsuit to require that the WAZE App allow for exclusion of streets which have been shown to have a negative impact and a continual threat to the quality of life in Los Angeles neighborhoods

Plante explained that the Waze commuter transportation app allows for the exclusion of streets detrimental to life. Isroelit seconded.

Tony Michaels said that at the last community meeting, Council Member Ryu wants the City to do something on a legal basis. There is precedent for Waze to exclude certain streets because of public safety concerns. We want relief from the overflow of traffic into our neighborhood. It will be a long process but a good first step.

Heather Carson noted that the language of this motion was cut off on the short agenda. Will that get us into trouble? Darnell responded that that's a mistake. There is supplemental documentation. I think it's fine.

Courshon noted that there are some typographical errors. In the second paragraph it says thorough motorists. Also, Waverly is misspelled. He

also noted that the 3rd paragraph first sentence doesn't read right. Maybe remove the "a". Additionally, City Attorney Mike Feuer's name is misspelled, said Courshon. Johnson, who drafted the motion, apologized for the errors.

A man asked should the idea be broadened to include Google Maps? This is a general problem for all of Los Angeles. He wants to add his street to the list. Johnson responded that the Google suggestion is fabulous. Isroelit suggested adding the language "among others" for streets. Carson asked can you submit a letter from the committee and then the Secretary can certify it?

9.2.(Transpo & Neighborhood Safety)SLNC submit a CIS in support of Council File 17-1311 to implement recommendations of the State of the Street Related Infrastructure Programs in Los Angeles Report

Plante made the motion. Courshon seconded.

Tony Michaels said that Lilia produced this 400 page report. It's very extensive. The City operates in a very decentralized way. She wants to bring the City into the modern age. The major recommendation is to fold transportation into the Department of Public Works.

Johnson said we don't believe this was received by the Board so we will postpone it for the July meeting. Lee Sherman said I couldn't access the link. *Johnson said we'll postpone the item to July.*

9.3.(Transpo & Neighborhood Safety)SLNC submit the a letter in support of banning mylar balloons.

Plante made the motion. Isroelit seconded.

Tony Michaels said that this came out of DWP meetings regarding power outages last summer. One outage was the result of a mylar balloon incident. They've caused thousands of outages throughout the state, along with fires. Now there are loose regulations. DWP has a fact sheet about mylar balloons. This is also a safety issue as mylar is metallic. There are a lot of issues. There was a state assembly bill that didn't get out of committee because of a balloon lobby.

Taryn Poole asked is there a way to get this information to the very active Mom's Club in neighborhood? That can help quite a bit. Johnson added that if this approved, we'll promote the heck out of this.

Courshon commented that the second sentence doesn't make sense. Silver Lake did have a serious outage because of a mylar balloon. We've had so many outages.

Carson asked Seamus Garrity can we tie in the environmental issue with this to get it passed? This is AB8709 from a couple of years ago, said Courshon.

Johnson said we can cc Assembly Member Friedman and seek her endorsement. Kate Hudson said don't just target moms, target everyone. Johnson said there is a very active Mom's Club in Silver Lake and this is something that they would like to take on.

9.4 (Plante) Support AB 2263 (Designated historical resource: conversion or adaptation: required parking): This bill incentivizes historic preservation and adaptive reuse of existing structures by reducing parking requirements. AB 2263 requires a local agency to provide the following incentives for a development project where a designated historical resource is being converted or adapted. A local agency will provide no additional parking for residential located within ½ miles of major transit, and a 25% reduction in required parking for nonresidential. This does not supersede existing local historical preservation or adaptive reuse ordinances, and is modeled after parking incentives in LA and Glendale.

Plante made the motion. Derakshan seconded.

This is to support Assemblymember Friedman's bill. Many of these buildings are from the 1920s and 1930s. Parking for some of these buildings could be destructive.

Seamus Garrity explained that Assemblymember Friedman began her career in historical preservation societies. She wants to incentivize preservation of these architecturally rare buildings. If the ordinance requires parking at one of these buildings, this does not supercede that. This is her bill. The intention is to protect buildings that she feels are very important.

Johnson asked is there a way to prevent certain businesses for example, Olive Garden, that would cause lots of cars where parking would be required and would cause more congestion? Garrity said that in the bill now, it allows for cities to have their own ordinances.

Courshon commented that normally these things go through urban design committees first so I'm slightly confused. Have these properties been designed as historical? Garrity replied yes.

Plante noted that we had a very tight time frame for this. Garrity said that it's time sensitive because the next meeting is in July and the legislative deadline will be shortly thereafter. It's already passed the assembly.

Carson asked the CIS goes to the Council file for the State? Garrity said yes. The Los Feliz Neighborhood Council has already done this. Johnson said the CIS would be on file with the City Council who would refer it to the State regarding assembly bills. Garrity said your letter would say that the SLNC supports this. Last year you wrote a letter, not a CIS.

Ringuette suggested that the actual motion read that a local agency will not require additional parking? Garrity said that September is the deadline to get a bill passed.

Johnson asked how can we make this happen so we can adjourn the meeting without ordering breakfast? Garrity said to support the bill. Johnson asked can the maker of the motion accept a friendly amendment with a simple sentence to attach to the CIS?

Courshon said we should write that sentence right now.

Plante read "The Silver Lake Neighborhood Council supports bill AB2263 which will work to incentivize historic preservation and adaptive reuse of

qualified existing historical structures by reducing parking requirements on historic structures.”

9.6 (UDP) Recommends support for a full line of alcohol sales with live entertainment for 33 Taps at 3725 W. Sunset.

Plante made the motion. Derakshan seconded.

There will be an amendment: The hours will end at 11pm during the week, Sundays to Thursdays and at midnight on Fridays and Saturdays. The speakers off at 10pm.

Gary Benjamin, the representative, is here along with Ryan Roy, the owner.

We hosted a community open house. We sent out mailers to everyone within 500 feet about 40 people attended the event. We continued door to door outreach. 14 people signed letters of support. There were also 88 letters from broader Silver Lake. Several neighbors spoke at the Committee meetings in support saying what the restaurant meant to them. The Committee agreed that the owner had put in the work.

Glen Harrell asked how many people attended the open house and weren't happy? Benjamin said none. No one opposed. A couple of them were ambivalent. Some 14 people signed letters of support from the open house and the Committee meeting. Plante added we didn't receive any letters of opposition.

Melissa Samuels asked why would the community support this? Benjamin responded that lots of people really like the restaurant. The extension of hours allows options for this type of restaurant with affordable quality food options that people appreciate. They were excited about that.

The owner Ryan Foy said we offer something unique to the neighborhood. There is beer, bingo, and Ru Paul events. Many people feel like this is their second home.

Courshon commented that there is an 11pm closing on patio during week. 12pm on midnight. Speakers off at 10pm. Poole asked which way do the speakers face? The owner said that the patio speakers face Sunset Boulevard and the parking lot.

Poole expressed concern about the use of a microphone. That can be extremely disruptive. Benjamin said we did go into lots of detail about that at the second Urban Design Committee meeting. There will be manual checks of sound levels at 50 feet into the parking lot. Live entertainment has been narrowed to a background dj with one microphone and trivia events and organizations that utilize that location. There will be no bands or DJs. You can't really hear sound for outside. Kate Hudson said I've been there. I can assure the Board that it's not loud or obtrusive.
